## **Program Benefits on Business Rentals:**

- Unlimited Mileage included on rentals rented and returned in the same city.
   (\$125 fee for One Way Rentals over 500 miles)
- Minimum rental age of 20 without an underage driverfee.
- Loss Damage Waiver and Liability coverage included in rental rate.
  - o No charges or fees for loss or collision damage to rental vehicle.
  - Third party liability limits of \$100,000,000
- International Discounts where law permits.
- Fee waived enrollment in Hertz Gold Rewards Program.

#### **Reservation Process:**

#### 1. Hertz.com:

- A Corporate Promotional Discount number (CDP) will need to be entered to obtain State rates and benefits.
  - If you do not know your CDP number, please contract Nadika Perera at Nadika.perera@hertz.com.
- You will need your driver's license, state employee identification card, and a Credit Card under your name to rent a vehicle.

#### 2. Direct bill reservations:

- Hertz provides two direct bill options. Please contact Nadika Perera

- You will need a direct bill account number and access to a special direct bill website for Direct Bill reservations.
- If your agency does not have this information or you need a new direct bill setup, please contact Nadika Perera @ Nadika.perera@hertz.com.
- It would take 10-12 business days to setup direct bill.
- Direct bill reservations will not require a form of payment at the time of pickup.

- Please provide your discount code number (CDP) to the agent or Direct bill number. This will put the rental under the State Contract and benefits.

- Please make sure to have your discount code number (CDP) to provide at the counter. <u>Direct bill numbers are not accepted at the</u> <u>counters.</u> Direct bill reservations have to be made prior to coming to the counter.
